#### Yard of Month

Commissioners previously agreed on \$100 to recognize a home with attractive yard. Nothing is being given now. Instead, a sign would be placed in the yard. If a homeowner wins more than once per year, they may be eligible to win a monetary prize or gift card. Information would be posted on the website. One of the big box stores (Home Depot, Lowe's, Walmart, etc.) might donate a gift card for this.

#### Night Out Against Crime

Event will be October 13 at 7 pm at 11259 Fernley. It will be catered with music. Residents should bring chairs and fellowship with neighbors. Flyers need to be passed out in neighborhood and emailed. It may be possible to get donated food and other items from stores like Winn Dixie but this must be requested months in advance. The entire event is \$700 below budget.

#### Cleanup Event
